### Lower Income Tax

Raise the tax-free threshold from \$18,200 to \$40,000 through cutting government waste and subsidies.

### Streamline the Bureaucracy

We are advocating for a Federal Convention to streamline the duplication of State and Federal departments.

### Flexible Childcare Support

Childcare subsidies to go directly to parents, using vouchers to provide flexibility to parents inc shift workers.

### Public Bank & Insurance Office

We want to stop the closure of bank branches, ensure cash is available and bring down the cost of insurance.

### Reduce Immigration

Our immigration rate is unsustainable. Immigration MUST be cut to less than 100,000 per year.

### Infrastructure Bank

We will restore Commonwealth ownership of infrastructure using an infrastructure bank to fund it.

### Voluntary Superannuation

We want people to save for their own homes faster and to pay down their mortgage before they retire.

### Abolish Renewable Subsidies

Subsidies on renewable energy should be abolished. We must focus on practical measures to protect our environment.

### Independent Judicial Commission

The judicial system requires scrutiny and oversight by a dedicated independent body.

### Education Reform

Education should be a competition of ideas and devolved where possible to schools, communities and parents.

### HECS Reform

20% discount on upfront or extra repayments of debt, and HECS for teachers and nurses to be abolished.

### Whistleblower Protections

We aim to introduce stronger protections for whistleblowers, so they are not bullied into silence.

### Defending Australia

Inquiry into ADF recruitment failures, as to why capable Australians are refused entry into the Defence Force.

### Energy Policy, not Ideology

We support all types of home grown base load energy. This includes coal, nuclear, gas and hydro.

### Primary Industries

People First stands firm in protecting Australia's agriculture, mining, logging, and fishing industries.

### Longer Fixed Home Loans

Longer loans will alleviate cost-of-living burdens and provide financial stability to homebuyers.

### Health Policy

People First will improve quality assurance, accountability and transparency in healthcare.

### Environment Policy

We will focus on practical measures that will protect Australia's environment and biodiversity, not ideology.

### Protect Freedom of Speech

We will lobby to enshrine freedom of speech in the Constitution by holding a referendum at a federal election.

### Support Farmers

People First will allow farmers and small business to collectively bargain against big corporations.

### Cut the Beer Excise Tax

Slash the beer excise by around 50% for beer with an alcohol content above 3%, and standardised to 20 cents a litre.

### Cross-Media Ownership Reform

We support non-biased media. Media should be restricted to owning only two of the three major mediums for communication.

### Income Splitting For Families

Allowing parents to split their income, to ensure families are taxed the same for a given family income.

### BAS Reform for Easier Business

We'll help small business by lifting the GST reporting from \$75,000 to \$250,000.
