A PLAN FOR PROSPERITY...

The major parties have focused on themselves rather than solutions, leaving everyday Australians struggling. **People First** are committed to fighting for effective policies and providing the leadership Australia deserves.

Lower Income Tax

Our first priority is raising the tax-free threshold from \$18,200 to \$45,000, funded by slashing government waste and subsidies. We will let families income-split to further lower taxes.

Flexible Childcare Support

We believe childcare subsidy payments should go directly to parents. Shift workers cannot always use childcare centres while FIFO and part time workers are forced to pay for childcare they don't need.

Voluntary Superannuation

Superannuation should be voluntary so people can own a home sooner. Home ownership is critical to ensuring our children are raised in a healthy and secure environment.

Streamline the Bureaucracy

We are advocating for a Federal Convention to streamline the duplication of State and Federal departments. Taxpayers cannot afford to pay for two Education, Health, Environment and Energy Departments.

Public Bank & Insurance Office

A Public Bank and Insurance Office can ensure accessible and affordable financial services. We want to stop the closure of bank branches and bring down the cost of insurance.

Infrastructure Bank

Australia should not rely on foreign capital to fund infrastructure. Australians should fund, build and own their infrastructure. A government-owned Infrastructure Bank will do this.

HECS Reform

We are advocating for a 20% discount on upfront or extra repayments of debt, and HECS for teachers and nurses to be abolished.

Reduce Immigration

Australia's immigration rate is unsustainable, impacting the cost-of-living and housing affordability. We're advocating for immigration to be cut to less than 100,000 per year.

Abolish Renewable Subsidies

Subsidies on renewable energy should be abolished. We must focus on practical measures to protect our environment such as removing plastic waste, preventing soil erosion and eradicating feral pests.

Education Reform

Education should be a competition of ideas and devolved where possible to schools, communities and parents. School curriculums should be delegated back to State Governments and schools.

Better Whistleblower Protections

Many government employees are afraid to call out wrongdoing for fear of reprisal. We aim to introduce protections for whistleblowers, so they are not bullied into silence.

Independent Judicial Commission

We believe the judicial system requires scrutiny and oversight by a dedicated independent body to maintain integrity in the judicial process. Judges must be held to account too.
